#### New SHIN-NY Spotlight Video Highlights Care Coordination for Older Adults in Rochester

NYeC recently completed the newest video in the SHIN-NY Spotlight series, this time highlighting Lifespan of Greater Rochester, which is a non-profit serving about 30,000 older adults and caregivers every year. Lifespan connects to the Rochester RHIO to access the SHIN-NY.

Founded in 1971, Lifespan offers more than 30 services for older adults in the community, including assistance for caregivers of people with dementia/Alzheimer's, assisting with Medicare, health and wellness classes and workshops, and elder abuse intervention and prevention programs.

In the video, Lifespan leaders talk about how access to realtime health data in the SHIN-NY through the Rochester RHIO improves the services they provide and assists in ensuring better healthcare outcomes for their clients.

## The SHIN-NY Selected as a Gravity Project Pilot Site to Further Social Determinants of Health (SDOH) Data Exchange

The SHIN-NY was selected by Civitas Networks for Health, in partnership with the Gravity Project and with funding from the Robert Wood Johnson Foundation, as one of four new early-stage pilot projects addressing public health and/or health equity use cases. Selected pilot sites are receiving one-to-one technical assistance from Gravity Project Subject Matter Experts in Gravity deliverables, social care data standards and social care interoperability, and are participating in a learning community that allows for shared learning across the sites.

From the Civitas Networks for Health Press Release: "The purpose of this initiative is to improve accessibility, knowledge, and capabilities for exchange of Gravity terminology standards with a focus on public health and health equity use cases; strengthen capacity for viable, cross-sector data sharing partnerships; and increase communication and collaboration for coordinating health and social care services among integral parties such as health care payers, providers, patients, community members, vendors, public health, health information exchanges, and community-based health and social service."

With efforts led by the Bronx RHIO and New York eHealth Collaborative, all six QEs across the SHIN-NY are working together to implement statewide standards for the ingestion and handling of social risk data, utilizing Gravity Project terminology and coding standards to ensure a consistent approach across the state.

## Rochester RHIO: Healthcare Sector HRSN Solution Workgroup Convened in Finger Lakes Region

The Rochester RHIO and Finger Lakes Performing Provider System (FLPPS) have convened a community workgroup to begin collaborative solution design on sharing, standardizing, and exchanging Health-Related Social Need information across the healthcare sector and beyond. As our communities continue to develop workflows and screenings to support care transitions and coordination efforts, the healthcare sector is focused on identifying and addressing the social needs of their patients. There is a critical need to share this data from provider to provider across healthcare sectors for effective and timely care.

To ensure a comprehensive approach to this effort in the Finger Lakes, the community workgroup, titled Healthcare Sector HRSN Solution Workgroup, convened this summer. Its membership includes health systems, FQHCs, social care networks and other critical stakeholders. As co-chairs, Rochester RHIO and FLPPS are facilitating discovery, consensus building, and solution design prototyping. The goal is to enable care workflows that address patients' social needs and improve health outcomes.

This work is in service of the social care integration goals of the pending 1115 Medicaid Waiver. This workgroup and its outputs will act as an incubator for the success of waiver readiness and HSRN workflow implementation.

## HEALTHeLINK Awarded \$1 Million in Federal Funding to Enable Availability of Advance Directives at Point of Care

HEALTHELINK has been awarded a \$1 million cooperative agreement over the next two years from the Office of the National Coordinator for Health IT (ONC) to aggregate advance care planning documents from across the community and make electronically available to treating providers who need to know a patient's wishes at the point of care.

"While patients may have documentation in their physician's office or a hospital medical record, studies have shown that only one third of emergency department patients have advanced planning documents such as living wills, health care proxy, do not resuscitate, and medical orders for life-sustaining treatment, to guide end-of-life treatment, and when they do exist, it's not easily accessible when and where it's needed" said Dan Porreca, president and CEO, HEALTHELINK. "The need to have this documentation electronically available is important to ensure that a patient's wishes are known and adhered to and is expected to increase as a result of the urgency in advance care planning brought on by the COVID-19 pandemic and as the baby boomer population ages. In addition, the cost of care at the end of life cannot be overlooked and will be impacted by adhering to patient's wishes."

The funding is being provided through ONC's Leading Edge Acceleration Projects (LEAP) in Health Information Technology program. HEALTHeLINK is the only recipient of funding in the country in the 2023 LEAP project category – "Exploring the Use of Advanced Fast Healthcare Interoperability Resources (FHIR) Capabilities."

### Bronx RHIO Supports CDC-Funded Track PCC Project

The Centers for Disease Control (CDC) funded Track Post COVID-19 Complications Public Health Surveillance Project (Track PCC) is a partnership between the Bronx RHIO, Beyond HIE, Comagine Health, Utah Health Information Network (UHIN), and Boise State University (BSU) to report COVID-19 related data to CDC for public health surveillance purposes. The goal of this project is to better understand the lasting impacts of COVID-19, to track the burden and distribution of the virus among diverse communities in the Bronx and in the state of Utah, and to collect extensive data on post-COVID complications or Long COVID.

A unique aspect of this project lies in the collection of data from two health information exchanges (HIEs) for surveillance rather than traditional electronic medical record data collection from multiple sites. This collaborative effort started with supplying clinical data on past COVID cases from both HIEs. In addition, Bronx RHIO is starting an Active Surveillance protocol to collect data prospectively from patients at Montefiore Medical Center, Essen Medical and BronxCare for the next two years. People who receive care at those sites and are diagnosed with COVID can consent to participate in completion of four surveys about their symptoms and experiences. Their data will be aggregated by the RHIO and provided to CDC in de-identified form to inform them in detail about the current/ongoing experiences of COVID patients.
